Please make sure to get a confirmation number and you can go to RCI cruise lines and log on with this number.

# 13th Annual Reunion—Final Call By Walter Alexander

This is the final newsletter notice for the 2009 Call to Reunion aboard Royal Caribbean International's "Enchantment of the Seas" departing from Fort Lauderdale on October 26. If you plan to attend but have not reserved a cabin, please call our Cruise Host, Brian Forrester, at once. RCI has already required us to reduce the number of cabins we have blocked so that they can make them available for sale to the general public, but we still have a few cabins left. A reduced deposit of \$150 per person is required at time of booking. The deadline for final payment is July 20, 2009. These may be paid by credit card and are refundable in accordance with cruise line standard policies. Passports are required, so apply for yours at once if you don't have it yet.

If you want to arrive in Ft. Lauderdale the day prior to the cruise, make a reservation at the Marriott Ft. Lauderdale Airport & Cruise Port Hotel and request the special DLA room rate of \$79 plus tax.

Please note that Brian's travel company has switched their franchise from "Cruise Holidays" to "Holiday Cruises and Tours." His new e-mail address is brian@hct-travel.com, but his phone number remains the same (800) 998–1228. When you make (or made) your reservation, Brian will give you a cruise Reservation Number. You should then go on line to RCI's web site www.royalcaribbean.com, open "Have a Reservation? Before You Board," insert your reserva-

tion number, complete the "on-line check-in," and print "Set Sail Pass" for each passenger in your cabin. You will need this document when you arrive at the pier for boarding.

After boarding the ship, go to the Conference Center where you will receive the DLA Welcome Aboard packet. This will contain the items you normally receive at our land based reunions. Each evening RCI will provide you a list of the following day's activities for all passengers. Your DLA welcome packet will contain a Plan of the Day for our special reunion activities with times and locations. The preliminary plan is:

### PREPARATIONS FOR DEPARTING THIS LIFE by Howard Dobson, Roster Administrator

Shipmates,

Although we hope that your day and those of our shipmates are in the distant future, each of us should prepare for that unpredictable day. As such, I ask that you place this newsletter article with your will or other important papers. It contains information for informing the Destroyer Leader Association (DLA) of your passing.

The reason why I am asking you to inform the DLA is that our shipmates are passing, and for some reason, months and often years pass before the DLA becomes aware of the death—if we become aware at all. Your service to your country was not only important to your country, but to the DLA. We feel that your having placed your life on the line to defend the freedoms that we enjoy today in this country must not be ignored. As such, we intend to honor your service to our country during the Memorial Service held at a reunion subsequent to your passing.

All of us served during the Vietnam and Cold War eras. These conflicts occurred to deter Communism that threatened democracy around the world. Each of us had a significant role during those periods despite any seemingly insignificant job we performed. Every job contributed to the missions although many service personnel paid the ultimate sacrifice or sustained debilitating injuries at the time. Fortunately, veterans of our member ships sustained no combat-related deaths or injuries during the eras, but by serving our country at the time, we were willing to do what was necessary to protect our freedoms then and for future generations. For this, we are thankful for your service and feel that we must recognize it after your death as is customary at that time.

Do we have your correct phone number? How about your e-mail address? In March 2009 during a mass e-mail to individuals on our roster that served as a reminder for the 2009 cruise reunion, I received about 150 undeliverable e-mails. Six of those were members who dues are paid through 2009 or beyond, and two are Lifetime Members. Another three were individuals whose dues expired in December 2008.

Changes to e-mail addresses are most overlooked as they occur frequently in efforts to obtain better deals. E-mail addresses are important to the DLA as this form of communication has essentially no cost to the DLA and the mail recipients. E-mail communications will likely become the preferred means of communication in the near future to reduce expenditures of the DLA.

Phone-number changes are also overlooked because many people seek to reduce their utility expenses. Many are either dropping their home-phone service for cell phones or changing cell phone providers for better deals. Without correct phone numbers, we cannot contact you easily to obtain your correct e-mail addresses when they differ from those on the roster.

By receiving the newsletter via e-mail, you will help ODC reduce the costs of printing and postage. We have not raised the cost of dues for more than ten years despite continuously rising postage rates. If you elect to receive the newsletter via e-mail, you will receive it in color and about five days earlier than by postal mail. Please consider this lower cost option. We'll be discuss-

ing this at the Business Meeting.

If you do not have e-mail, or if you simply don't want to receive the newsletter e-mail version, no response is required, and you will continue to receive the paper version by mail as you do now.

Obviously, some people do not have e-mail, so we are still going to be printing and mailing some paper copies. But the fewer we have to mail the better when it comes to paying the bills. During recent years a substantial portion of each member's membership fee (dues) has gone to pay for the printing and mailing of this newsletter. Producing a newsletter is a high priority,

but very little is left over to cover other activities or projects. We have not raised the Chapter portion of membership fees in recent years, but that, or a special assessment to cover paper copy mailing, could be a next step; we don't want to do either if it can be avoided by reducing costs.

# FREE 411 TELEPHONE-DIRECTORY SERVICE

At last, a 411 information system that is really free exists thanks to the internet giant, Google. I learned of this service through an article in American Submariner, a publication of the United States Submarine Veterans, Inc. The service is limited to businesses only—no personal numbers. There is no charge for requesting and receiving the directory assistance, AND there are no advertisements or commercials to listen to. Now, you do not have to invest in mobile internet service or buy an expensive GPS unit, and you don't have to note or dial the number of the business that you wish to contact—the service dials the number and connects you.

All you need is a telephone—any telephone, home or mobile. You dial 1-800-GOOG-411 (1-800-466-4411). Then provide a city and state and the name of the business or a type of business. Afterward, you are connected to that business.

Although the directory assistance is free, your phone carrier might charge you for the phone call itself as determined by the plan that you have. For example, if you call during the day with a cell phone, you will be charged for the call as you would for any other daytime call. If you have unlimited cell phone minutes in late evenings and weekend or unlimited calling on a home phone, you will not incur a charge for the call.

I hope that you find this information useful.

#### Opening Remarks, By Mike Bugara:

Want to thank everyone for coming and participating in the meeting and tireless efforts this year, past years, and in the coming years for making this meeting a success. This year we are doing very well, except with a few room issues with the hotel. Hope those problems have been corrected. Comments from Curt Hanson, that things were coming along, with the room problems.
